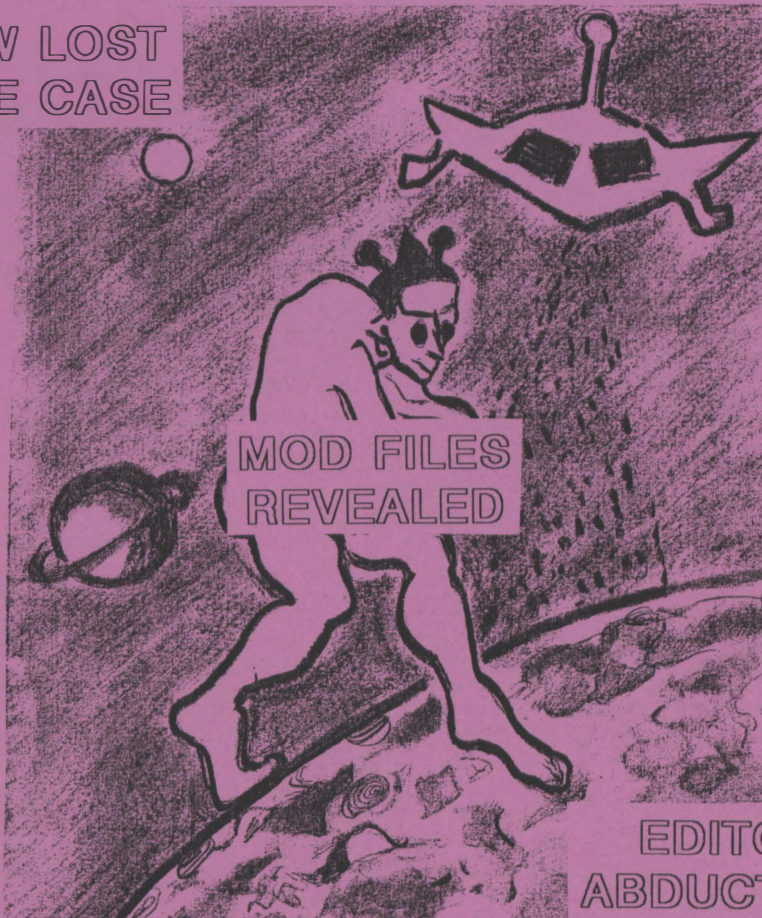

EDITORIAL**CELLULAR MEMORY - ABDUCTION DANGER??**

More and more spectacular cases are being reported of medical patients who have received transplanted vital organs from recently deceased donors, suddenly develop different personalities and take up unusual pastimes they had previously taken no interest in. Eating and drinking preferences may also be markedly changed. Organ transplants, once a rare event, are becoming commonplace and, thus, an increasing number of interesting patient histories are coming to light. Awareness first published information on this subject in Vol 27 No 1, pp 11-19, in an article by Malcolm Robinson.

Unfortunately there is a tragic tale or two amongst the many who benefit from transplanted organs. We hear of a man who committed suicide after receiving a transplanted heart 12 years previously from another suicide victim. He had in fact married his donor's former wife.

Selecting from many case histories available, details of heart/lung transplant, Claire Sylvia, have recently been published. The 47 year was dying from a disease called primary pulmonary hypertension, when in 1988 she received the organs of an 18 year old youth who had been killed in a motorcycle accident in Maine, USA. The identity of the donor was withheld at the time for ethical reasons. This transfer of a vast amount of tissue was a pioneering operation at the time and the patient has survived 20 years. Within days of leaving hospital, Claire experienced a craving for the taste of beer, a drink she had never been interested in before. This was followed by a desire for certain foods she hadn't liked before the operation, such as Snickers bars, green peppers and Kentucky fried chicken takeaways. Her personality was also changing in that she was becoming masculine - more aggressive and assertive than she used to be - and developed a lumbering walk which was remarked on by her daughter. Although her sexuality had not changed, she was mistaken by a lesbian by a woman she became friendly with at a conference.

She then had remarkable dreams in which she was vividly aware of being with a young man called Tim Leighton? and woke up knowing for certain this person was in fact her donor. As stated the hospital would not reveal the name of her donor, but Claire set out to find out who he might be by checking newspaper records of any young persons who had died in a motorbike accident a few days before her transplant surgery. She found a Timothy Lamirande who fitted the details exactly and managed to make contact with his parents and they were willing to reveal that all the unusual dietary habits and personality traits that Claire was picking up corresponded exactly with those of Timothy when last alive. (*Report: Daily Mail 9/4/08*).

What's all this to do with our subject you may ask? The example above and many others demonstrate that the "life force" (or whatever you care to call it) of a person can be overcome by a much more powerful energy from outside. In the case of a very ill person receiving a large amount of tissue from the deceased victim of an accident in their prime of life, there is now convincing evidence that shreds of the donor's personality are transferable to the recipient of his/her organs. If such things as "alien implants" exist, by the same token, they could in theory control the personality of the host by possessing stronger energy. Victims of "abduction" may have their minds taken over by a powerful external force which temporarily controls them and may give rise to self-harming. It is likely that abductees have

certain spiritual weaknesses which make them extremely vulnerable to takeover as repeater cases are fairly common.

There is no scientific method of measuring the human "life force" as it is likely to be controlled deep in the sub-conscious mind - an area not open to science. The evidence of "cellular memory" does, in my view, explain a great number of things that puzzle us.

I have recently experienced what might be the makings of an "abduction" scenario, when two foul smelling areas of something unknown were suddenly detected in my house in late April this year. These were definitely parcels of "energy" as they showed strong responses to dowsing methods which I specialise in. There was absolutely no rotting vegetation or dead animal life which could explain these circumstances, and the bad odours hung around in the same spots for a week in spite of attempts to remove them. You can read a fuller account of this on pages 11-12. Whether you think my evidence is related to the abduction scenario or not is entirely up to you.

CIUFOR is continually searching for new explanations and new approaches to the subject of Ufology. Remember there are more senses than just the visual which should be investigated, as illustrated above. A mountain of regurgitated material is now available on countless numbers of TV channels and DVD releases which offer very little in the way of new evidence. Viewing yet another programme on "Roswell" becomes very tedious. Only the sight of those retrieved alien bodies or craft would now be satisfactory after 60 years!

LATEST NEWS ITEMS

TUNGUSKA IMPACT CENTENARY: On June 30th 1908, a massive explosion occurred over a remote part of Siberia known as Tunguska. There was a colossal flash and a shock wave passed twice around the Earth. For two nights following the sky exhibited a brilliant glow over Europe and Asia which was similar to the aftermath of the disintegration of the volcano, Krakatoa, in 1883. The explosive power of the device has been calculated as 10-20 megatons at an altitude of 10 km or equivalent to a large hydrogen bomb. One frightening conclusion is that had it happened over the centre of London all buildings within the M25 corridor would have been destroyed! An estimated 800 square miles of forested terrain was flattened numbering around 40,000 trees, although odd ones were left standing near the epicentre.

Probably due to the political unrest of the time, World War 1 and the Russian Revolution, it was not until 1927 that a proper scientific expedition was sent out to verify the site and causes of the 1908 explosion. Explorer and geologist, Leonid Kulik, led the team and he returned again in 1930 and 1939. Kulik had to drag sledges across frozen ground for many miles as there were no roads in the region. Nearly 20 years had elapsed since the 1908 event and no obvious impact crater was ever found, although it was suggested that it might be below Lake Cheko, 5 miles from the epicentre.

If a very large meteor, asteroid or even a comet had caused the blast at Tunguska then a Moon sized crater would have certainly been found. It seems likely that astronomers would have forewarned about the event certainly spotting an approaching comet or asteroid before

it impacted, but there is no indication that any such advice or warnings were received.

We now have to look at other alternatives - a massive gas explosion has been suggested as the region has large deposits of natural gas below the top soil. The few witnesses interviewed by Kulik reported seeing a massive fireball in the sky. The similarities to a nuclear explosion give rise to the theory that an advanced space craft driven by atomic propulsion either crashed into the ground or impacted with a meteor in the atmosphere causing its complete destruction with a massive release of energy. Even more bizarre is the notion that the brilliant scientist, Nikola Tesla, was developing some advanced machine that remotely caused the explosion in Siberia in 1908.

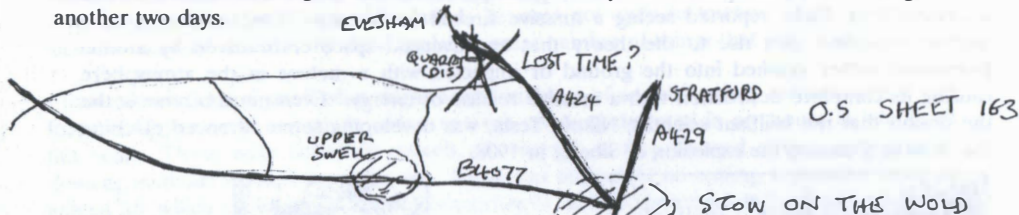
FALLEN TREES AT TUNGUSKA

Whatever the truth of the matter, there is no doubt that the Tunguska impact or explosion was a real event and a warning that a similar occurrence 100 years later could be an absolute catastrophe with a vastly increased world population and many urban conurbations with upwards of 20 million citizens. Would satellite warnings enable mass evacuations to take place in time? Of course if the energy release came from within the earth there would be no time to act as with earthquakes - most occur without the slightest warning except in well monitored areas such as the San Andreas fault in California.

NEW MISSING TIME INCIDENT: On Thursday, March 6th, 2008, Kevin, a close relative of our secretary, Fran, was driving home from work in Cheltenham in his 4x4 pickup vehicle along backroads through the Cotswold Hills to his home at Blockley, Gloucestershire. He would normally take ½ to ¾ of an hour to cover the journey including walking his dog who accompanied him most days but on this occasion was not on board. Thus Kevin was entirely alone and talking on his mobile phone to his step-son as he drove past a lonely spot approaching the A424 Evesham - Stow on the Wold road near a disused quarry at position SP 175 280 approx. around 3 miles from his home.

Suddenly the phone lost the signal, began flashing and went through the whole programme in the memory. In shock he dropped the phone on the passenger seat and stopped the vehicle. He then noticed the car was surrounded by a high wind which rocked the vehicle violently. (Hitherto there had been no noticeable turbulence on the journey). He picked up the mobile to redial his step-son, but then noticed a light was coming up some distance behind him which scared him. Then another car finally came past, at which point he seemed to become more alert and drove off in a panic - now feeling that something serious had

happened to him, but could not define what that experience was. Driving straight home, he then found his partner worrying where he was as the time was now 7 pm when his normal arrival was 6 pm. Thus an hour at least of missing time could not be explained, and Kevin described himself as being detached from mind and body. He continued to feel strange for another two days.



Fran informs that Kevin had never experienced or reported any UFO events before, and his phone call about the March 6th incident was completely unexpected. As usual there is scant evidence about what was happening during the missing time period and at what stage the process began. However the arrival of a violent, vehicle shaking wind has not been observed in previous case on our files.

THE SUN GOES UFO CRAZY! Britain's largest selling daily newspaper, The Sun, circulation c3,500,000, has suddenly started reporting UFOs in large numbers over the past 2 months (June-July 2008) which has been useful in revealing more cases than average with a media giant on board. Unfortunately most of the actual photographs reproduced are of tiny lights in the sky which could easily be "Chinese Lanterns", but alongside are artist's impressions of other worldly saucers and alien occupants, which no doubt has encouraged readers to report more incidents.

The June 20th Sun reported a police helicopter being attacked by a UFO as the 3 man crew were preparing to land near Cardiff on June 8th. The pilot banked sharply to avoid being hit and then launched into a high speed pursuit which had to be abandoned when fuel ran low. All 3 officers on board described the object as being "flying saucer" shaped. On June 25th the Sun produced a dossier of cases from the West Midlands and Welsh Borders including a fleet of UFOs hovering over an army base near Shrewsbury on the night of June 7/8th. The June 27th paper revealed a photograph of bright, multicoloured lights taken over the Brecon Beacons mountains by a university don. (*Reports are still coming in*).

In keeping with all the activity, the Sun set up its own UFO camp at the Berwyn mountains scene of the 1974 incident. (*Thanks to all members who sent in clippings*).

John Hughes, 68, said: "It made the house shake. I ran to the window and could see lights at the top of the hill, they were bright. I rang the police but they know nothing."

By the time families reached the site in daylight there was

nothing left, despite the scale of the "alien" explosion.

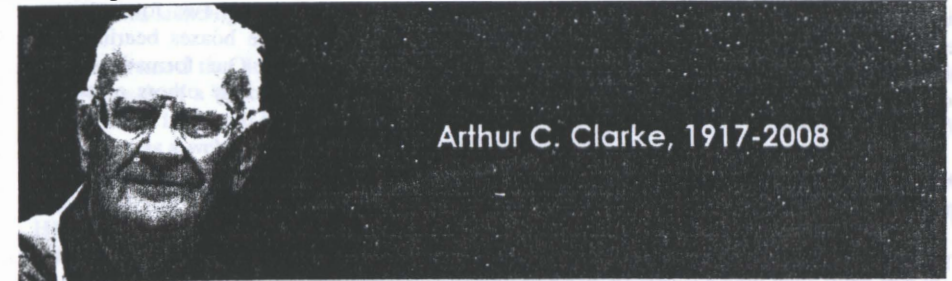

ARTHUR C. CLARKE DIES: One of the greatest scientific writers and visionaries of the 20th century, Arthur C. Clarke died on March 19th 2008 at the age of 90. He was at home in Sri Lanka where he had lived since 1956, although originally came from Minehead, Somerset.

Clarke wrote more than 80 fiction and non-fiction books in his long life and is best remembered for "2001, A Space Odyssey" whose advanced concepts were put to film by the distinguished director, Stanley Kubrick, in 1968. (*Strangely the talking and controlling computer, "Hal" was mentioned in the last Awareness*). However real time 2001 has shown space travel has not quite reached the levels envisaged in the novel.

A memorable series of television programmes were compiled under the title "Arthur C. Clarke's Mysterious World", which looked at all forms of paranormal activity and was introduced by Clarke himself. At the end of each episode he gave a critical appraisal of each aspect and gave some sort of bookmaker's odds of the veracity of the subject. Clarke turned out to be quite conservative in his assessments which contrasted quite sharply with his visionary writing.

In real life Arthur C. Clarke volunteered for the Royal Air Force in WWII becoming involved in top secret development of radar which may have germinated the seeds of his future career as a writer starting in the late 1940s. He was knighted in 2000, but had been subjected to certain allegations of child abuse in the years before which delayed the granting of his knighthood.

IN MEMORIAM

GEORGINA BRUNI 1947-2008: One of the leading investigators of the Rendlesham Forest mystery, Georgina Bruni, has died after a long illness on January 19th 2008. Her book entitled "You Can't Tell the People" was apparently a quote from Margaret Thatcher who she met in 1997. Georgina was extremely well connected and had business interests in many places. During a period when she was an investigative reporter she turned her attention to the UFO phenomenon in 1995. Georgina, although late on the scene, (the Rendlesham incidents dated from late 1980), was able to reveal many new witnesses hitherto unknown to the case and produced a meticulous account about Rendlesham which was launched at the King Henry VIII wine cellar at the Ministry of Defence Main Building in 2000 - a nice touch!

Following the success of the book, Georgina was in demand from the media and was seen on chat shows etc. Further UFO projects beckoned, but alas it was not to be.

EXPLODING UFO OVER VIETNAM: Press reports state that a UFO exploded over a remote Vietnamese island, Phu Quoc, on May 8th, 2008. Search parties found shards of grey "metal" up to 4ft long scattered over the ground. The remains are not thought to be those of an aircraft as none were reported missing in the area according to Vietnam, Cambodia and Thailand authorities.

Villagers in the nearby Cambodian province of Kampot reported a large explosion, and a day later found chunks of material near the coastline. An illegal activity could have been in operation involving a private aircraft which would then not be confirmed as missing. Until analysis of the "metal" shards is forthcoming, it would be unfair to speculate that the object that crashed was "unworldly".

CROP CIRCLES ON TIME BUT SPARSE: The 2008 crop circle season started in England on April 19th with a sketchy looking spiral design in rapeseed at Waden Hill near Avebury, Wilts. The crop was hardly in flower at this date so it was surprising a design appeared at this stage in the cycle. Three more rape formations arrived nearby in May in bright yellow rape crops, and these were delicately formed with fine line features. Continuing into June, Wiltshire formations appeared on a regular basis running into barley and wheat towards the end of the month. Astronomical information was being recorded in these designs according to some researchers.

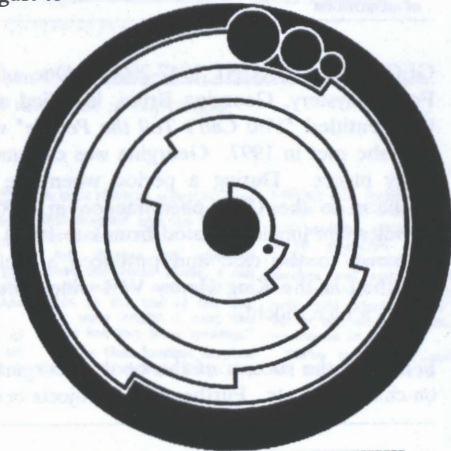
Elsewhere there were very few reports coming in to boost the numbers. Two formations near Wayland Smithy, Oxon look poorly executed and are likely to be hoaxes bearing in mind the standard of crop circles in this area over the past 3 years. One formation in Cornwall near Helston and another near Coventry appear to be the only others outside Wiltshire by early July.

Overseas formations are plentiful in Italy again and some very sophisticated designs have appeared in Germany during late June.

There has been no really hot weather in England, so the harvest may be later than usual. Hopefully there will be more activity in July and August to increase the numbers for 2008.

The diagram opposite shows a most interesting formation that appeared at Barbury Castle near Swindon on June 1st. The design shows a similar "ratchet" feature to the classic pictogram of 1991 which was in a field a few yards from here. At the time, the 1991 creation was the most original and sophisticated design yet seen.

Harping back to the 2007 season, a very late crop circle turned up in a field of abandoned barley in Wiltshire and was not spotted until November making this the latest formation recorded in England.



MOD FILES NOW RELEASED: The long awaited complete release of UFO files on the Internet was done on May 14th 2008 - at least the first 8 of many voluminous files covering the years 1981-87. The rest will follow over a period of time.

AGONY CORNER: (Anti-establishment comment on latest scares and cover-ups)
DAVID ICKE STANDS FOR PARLIAMENT! Our leading conspiracy theorist, the former BBC sports presenter and one time footballer, David Icke, was one of 26 candidates who stood in a by-election for the Yorkshire seat of Haltemprice and Howden on July 10th. Top Tory, David Davies, already the sitting MP, decided to stand down and reseek a mandate from the voters over the civil liberties issue of holding terrorist suspects for a 42 day detention period. This somewhat odd reason for holding a by-election was regarded as too trivial for the Labour and Liberal Democrat parties to field candidates, but may have encouraged every other Tom, Dick and Harry to have a crack at unseating Davies. The result was that David Davies returned with 72% of the poll, a majority of 15,355 votes over the Greens. Mr Icke trailed in with a paltry 110 votes - did the electors not realise the "Son of God" was standing!

It is understood that Icke was only using the platform of the by-election to warn people of the approach of a "global Orwellian state" and not to oppose Mr Davies whose stand he agrees with. If elected he could not swear allegiance to the Queen and in any case considers parliament as a web of lies, deceit and corruption!

CONSPIRACY UPDATE

HEATHROW AIR CRASH: The crash landing of the Boeing 777 at Heathrow on January 17th, 2008, has still not been explained after 6 months. The July bulletin of the Air Accidents Investigation Branch gives no update at all of its investigation into flight BA38. The fuel injection system seems to be the most likely cause of the near disaster according to official releases. They even propose that extreme low temperatures on the flight over Siberia may have caused the fuel to gel or solidify. The notion that jamming devices used in the Prime Minister's motorcade which arrived on the perimeter roads of Heathrow at the same time as the BA flight could be responsible, have not been discussed publicly. It is odd that no other 777s have been subject to inspections or grounded in the light of the Jan 17th crash landing.

BARRY GEORGE: The retrial of the man convicted of murdering charismatic BBC presenter, Jill Dando, is now underway, starting June 9th, 2008. The jury once again heard about the perverted sexual interests of oddball George, but was he capable of carrying out a murder with such precision that hardly a sound was heard? The trial was halted on June 30th when George and a juror both became ill.

DIANA - THE FINAL WORD: The final decision of the jury was that Diana and Dodi Al-Fayed died in a tragic accident. The judge refused to allow any possible conspiracy verdict about the Duke of Edinburgh and the secret services to be permissible - so what was left? Mohamed Al-Fayed has suddenly gone very quiet!

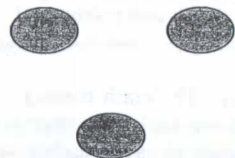
Date: 05/11/07 **Country:** UK

Mr NB was driving home from a firework display when his mother noticed three strange orbs in the sky. They slowed down so that they could get a better view and to observe them. The three orbs were "bobbing" up and down gently in unison giving the impression that they were joined to a single (invisible) (or) unseen object triangular in shape.

They decided to stop and Mr NB got out of the car but he states that by the time he did the orbs had moved halfway across the sky. Getting a clearer view he saw that in addition to moving they were also getting brighter and then dimming from dull orange to bright white. 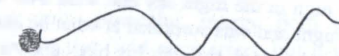

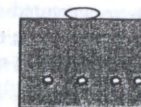

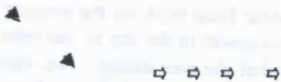

Ms A O was sitting in bed looking out of the window wearing her glasses she added, when she saw a small oval shaped craft flying north to south. It was tilting forward at an angle and moving quite fast. At first she thought it might be an aeroplane coming down to land but it stayed at a horizontal level to the ground and was not losing height. That sighting lasted approx. 8 seconds, then about 30 seconds later I saw another object exactly the same as the first. (same angle and size) the colour greyish silver moving at the same speed. I did not hear any sound – not even from the passenger plane.

Mr GAC was standing on the steps outside his home saying goodnight to his girlfriend when he noticed two round bright yellow lights which seemed to come straight down, stopped, then went south east at a right angle. he second one flew in exactly the same way as the first they were both very high in the night sky and went over the housing estate where he lived. It was a very clear and dry night and was surprised at what he had seen and decided to contact the local police and airport. He tried to look through his binoculars at the objects and could not see any tail or wing lights or anything that he could recognise as a conventional aircraft.

His girlfriend also states the object came down from very high in the sky at an angle and then went horizontal across the sky. She stated the 2nd light did exactly the same thing. She too looked into the binoculars and saw two circular lights with bright white light radiating from it

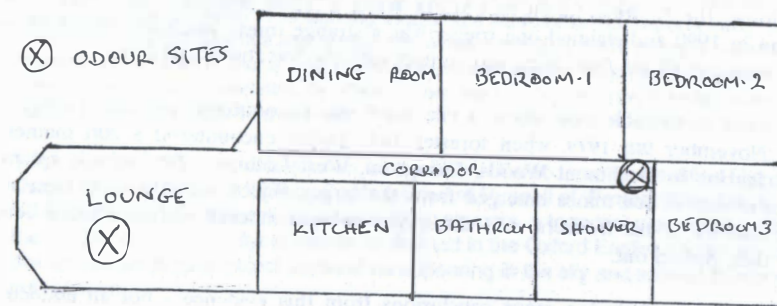

A cluster of colourful lights were photographed by a man in the early hours of Tuesday morning. The bright cylindrical spots were captured on camera by a Worcester man whilst he was photographing unusual cloud formations. He states he first thought they were spotlights but there was no cloud at all not even a haze present to reflect the lights therefore they must have been lights in the sky. The lights were stationary then shifted from left to right then faded away. He tried to work out what he had seen and discounted most of the obvious things that would be in the sky and realised that it must have been something very unusual.

During the last week of April 2008, my wife and I identified foul smelling odours in two parts of our bungalow. The aroma resembled the sweet sickly smell of rotting vegetable matter. However we ascertained there were no decaying flowers or plants anywhere near where the stench was picked up and moving furniture around we were unable to find any dead mice or insects. There were no signs of any odours outside and checking our composter also indicated that the decomposition taking place had very little or no smell to it. Thus it is unclear how these "parcels" of foul air came to be inside the premises. They also remained quite static in position during the week they were present. The diagram below shows a plan of the house with the locations of the bad air, which were not inside the bathrooms or kitchen where you might expect them.



Using dowsing techniques using a small pendulum, a quite powerful energy field was detected at the heart of the bad odour. Attempts to remove the field were tried, but it was about a week before we were certain that the infestation had gone.

I had previously encountered a similar smell in my car about two years ago when removing decaying garden waste to an allotment. The problem was that the odour remained in the car for several weeks after all traces of the vegetable matter had been removed and the vehicle given a good internal clean. So just what is going on here? As strong energy was detected at the centre of the recent problem there is some evidence that an unknown "intelligence" possibly is feeding off the fermentation process on dung heaps and traps molecules of gas inside the matrix of its construction, which are detected as foul odours by human noses. Could this "intelligence" also link into human minds or feed off them with the end result being an "abduction".

The above conclusions may seem far-fetched but does agree with the evidence from a number of abduction cases. In her book "ABDUCTED", Ann Andrews describes a situation relating to her son Jason who experienced almost continuous abduction events in his youth. She was having great difficulties in raising Jason at Hawksnest farm in Kent in the 1990s, as he was having violent mood swings and being sent home from school. He was claiming contact with aliens and odd markings were appearing on his body. He was being ridiculed by psychiatrists, and it was not until UFO investigator, Tony Dodd, was called that some sense of what was happening emerged. On page 111, Ann describes a smell that heralded the return of paranormal activity. It was a sweet sickly odour that pervaded the whole

house, something like burnt sugar but much stronger and unpleasant. The whole family were made to feel sick by it, and even their dogs stayed outside as long as possible. Every room deodoriser on the market was used to kill the smell but proved only a temporary solution. There had been previous occasions when a similar smell had been picked up, but never so bad and in the house. It even got into Ann's car and was so strong that none of them could bear to use it for a whole day. She lifted carpets, cleaned out cupboards and searched everywhere for the source of the smell, but could find nothing.

Suddenly the smell lifted completely, but then a spate of paranormal activity commenced with electrical equipment switching on and off, the hi-fi bursting into life when not plugged in and all the light bulbs in the house blowing at one go. The dogs growled as if intruders were on the premises, but nobody was ever found. Jason resumed experiencing night-time visits from aliens-----

In the same tome, the Andrews family met Maria Ward, a fellow abductee, who recalled her own abduction in 1990 and claimed one trigger was a strange musty smell like rotten leaves that she was aware of all the time there was contact with the "creatures". (P 174).

Perhaps the most memorable case where a vile smell was encountered was the "Livingston Incident" of November 9th 1979, when forester Bob Taylor encountered a 20ft diameter sphere in a clearing in Dechmont Woods, Livingston, West Lothian. Two robotic spheres with the appearance of sea mines emerged from the larger object, rolled towards him and attached themselves to his trousers. At this point he remembered an acrid smell being emitted and then passed out.

It would be unwise to draw too many conclusions from this evidence - not all abductees report strong smells before or during their experience - but there is an indication that there is at least a link to the abduction process. If an intelligence is present it may be interacting with human consciousness in certain vulnerable individuals and take over their minds for brief periods. Is the energy derived from non-human sources or even aliens? The widespread and similar description of "aliens" given by abductees in non-related cases may be accurate but the actual creatures are not physically present at the point of contact. The energy could contain some form of "tape recording" relating to a lifeform billions of miles away on other planets which is played back in a 3-dimensional fashion within the abductee's mind.

Distorted photographs of Jason Andrews speaking at conferences have been taken by CIUFOR webmaster, Ellis Taylor. This may be explained by the presence of strong energy around Jason's head which seems to have a permanent attachment on him. There may be reasons not fully understood why Jason is extremely vulnerable.

After two months, at the time of writing, there is no further indication of bad odours in my house, and the process that lead to the mysterious arrival in April remains a total mystery. If the smell just blew in, equally we should have been able to blow it away - but it would not budge for a week. Of course having two spots at opposite ends of the premises - they were about 30ft apart - strongly adds to the possibility that intelligent placement was involved and we may have been in danger, but I suspect we are not susceptible subjects. Readers should be careful to monitor their own premises or cars if a smell is suddenly detected without human cause and cannot easily be removed.

Unidentified Flying Objects (UFOs)

1. What is a UFO?

The first reports of 'flying saucers' being sighted were on 24 June 1947 from the Cascade Mountains of Washington state, USA. A private pilot, Kenneth Arnold, reported seeing nine strange objects that moved at tremendous speed across the sky 'like a saucer skipping on water'. His sighting triggered a wave of similar reports from observers in North America and across the world. On 8 July 1947 a report came from Roswell, New Mexico, that a disc-shaped object had landed on a remote ranch and had been removed for examination by officers from the US Eighth Army Headquarters. The age of the flying saucer had arrived.

The acronym **UFO** is an abbreviation for the US Air Force term 'Unidentified Flying Object.' It was coined in 1950 by Captain Edward Ruppelt of 'Project Blue Book', the USAF's official 'UFO project', to replace flying saucers, a term that was widely used by the media and public. A flying saucer as defined in the Oxford English Dictionary is 'a disc or saucer-shaped object reported as appearing in the sky and alleged to come from outer space'.

Although for the public and the media UFO has since become a synonym for 'alien spaceship,' for the military forces of the world it is simply refers to something in the sky the observer can see but does not recognise. In the vast majority of cases, investigations have discovered ordinary explanations for UFO reports such as bright stars and planets, meteors, artificial satellites, balloons, aircraft seen from unusual angles and space junk burning up in the atmosphere. However, there are some cases on record where no common explanation can be found. For the Ministry of Defence, these types of report remain 'unidentified' rather than 'extraterrestrial'. Some branches of the MoD, such as the Defence Intelligence Staff (DIS), prefer the term **UAP** (unidentified aerial phenomena) to describe those UFOs that remain unidentified. UAP does not imply the existence of an 'object' of extraterrestrial origin.

2. UFOs in the early 20th century: 1909-1950

An understanding of the factors that lay behind the British government's interest in the UFO issue can be found by studying the range of documents available at The National Archives. The vast majority of the records are found in the post Second World War period. This reflects the growing post-war fascination with the idea of UFOs as extraterrestrial visitors, as portrayed in popular science fiction films such as *The Day the Earth Stood Still* (1951). In contrast, official policy was restricted to establishing whether UFO sightings could be considered to be a threat to national security. During the Cold War, for example, the major threat came from behind the Iron Curtain. Once Soviet aircraft were discounted, the identity of a UFO was of no further interest to the British military.

To understand the origins of the British government's interest in UFOs it is necessary to look back to an earlier period of 20th century history. In 1909 and 1913 **phantom airships** - dark cigar-shaped flying objects carrying searchlights - were sighted at night moving over many British towns and cities. As tension grew in the build up to the First World War, the media and some politicians accused the Germans of sending Zeppelin airships to spy on dockyards and other strategic areas around the British coastline.

In October 1912, when sightings of an unidentified aircraft were made over the Royal Navy torpedo school at Sheerness, Essex, questions were asked in the House of Commons. This led the First Lord of the Admiralty, Winston Churchill, to order an investigation. This failed to establish the identity of the aircraft but the Germans were widely believed to be responsible. The relevant papers are found in [AIR 1/2455](#) and [AIR 1/2456](#).

Both the War Office and Admiralty investigated further sightings of unidentified airships, aircraft and mysterious moving lights. These were usually seen at night and reported the military authorities from many parts of the British Isles during the First World War. In 1916 a War Office intelligence circular concluded that 90percent of the reports could be explained by bright planets, searchlights and natural phenomena ('Alleged Enemy Signalling 1916', [WO 158/989](#)).

More sightings of aerial phenomena were made during the Second World War by RAF aircrew. These included balls of fire and mysterious moving lights that appeared from nowhere and appeared to pursue aircraft operating over occupied Europe. American pilots dubbed these UFOs '**foo-fighters**', from a character in a comic strip whose catch phrase was 'where there's foo there's fire.' Although the foo-fighters did not appear to be hostile the sightings caused considerable alarm in the Allied forces as they prepared for the invasion of France. The RAF began to collect reports from 1942 and later in the war, the Air Ministry shared intelligence on the subject with the US authorities. They assumed the objects were German secret weapons, such as the Me262 jet fighter. At the end of the war no traces of advanced aircraft or weapons that could explain the 'foo fighters' were found by the Allied occupying forces. In addition, intelligence officers such as Dr RV Jones discovered that German pilots had observed similar unexplained aerial phenomena. (See bibliography)

Air Ministry reports on 'night phenomena' are at [AIR 2/5070](#) while reports from aircrew with Bomber Command's 115 Squadron in December 1943 can be found in [AIR 14/2800](#).

At the end of the war both the War Office and Air Ministry became involved in an investigation of mysterious **ghost rockets** sighted over Scandinavia. Initially senior intelligence officers at the Air Ministry believed the 'flying bombs' (RV Jones memoirs, 'Most Secret War' chapter 52, pg 510-11, 1978) were of Soviet origin, possibly as V2 rockets from the captured Nazi rocket plant at Peenemunde. Dr RV Jones, who became Director of Intelligence at the Air Ministry in 1946, was sceptical of this theory. Drawing upon his wartime experiences, he believed the scare was triggered by daytime sightings of bright meteors in countries that feared Soviet expansion. Reports and correspondence between the Foreign Office, Air Ministry and the British air attaché in Stockholm are contained in [EO 371/56988](#) and [EO 371/56951](#). An air intelligence report on the 'ghost rockets' of 1946 can be found in [AIR 40/2843](#).

Reports of ghost rockets preceded by six months the first sightings of 'flying saucers' over the mainland of the United States. In December 1947 the newly created US Air Force set up a project, code-named **Sign** to investigate the growing mystery. USAF Lieutenant General Nathan F Twining's initial conclusion was 'the phenomenon reported is something real and not imaginary or fictitious.' (See further reading)

3. British Government interest, 1950-1951

The British Government did not begin any official inquiry into the UFO mystery until 1950. During the spring and summer of that year a large number of 'flying saucer' sightings were made in Britain for the first time and the media started to take an interest. Two Sunday newspapers serialised the first books on the topic that had been published in the USA and this led a number of senior figures, both in the establishment and the scientific community, to treat the subject seriously for the first time. The *Sunday Dispatch* was encouraged to publish stories by Lord Louis Mountbatten, who was later to become Chief of Defence Staff. Mountbatten was one of a small group of influential military officials who believed UFOs were real and of interplanetary origin.

Another senior official who took reports of UFOs seriously was Sir Henry Tizard. He is best known for his work on the development of radar before the Second World War. Post-war Tizard became Chief Scientific Advisor to the Ministry of Defence and came to believe that 'reports of flying saucers should not be dismissed without some investigation' ([DEFE 41/74](#)). It was as a direct result of his influence that the MoD was asked to set up a small working party to investigate reports of flying saucers under the Directorate of Scientific Intelligence/Joint Technical Intelligence Committee (DSI/JTIC).

The Flying Saucer Working Party operated under such secrecy that its existence was known to very few. However, a reference to a study of flying saucers emerged in 1988 when a file of correspondence between Winston Churchill and the Air Ministry was opened under the 30-year rule, [PREM 11/855](#). On 28 July 1952 the Prime Minister asked Air Minister: 'What does all this stuff about flying saucers amount to? What can it mean? What is the truth? Let me have a report at your convenience.' The response, dated 9 August 1952, began 'The various reports about unidentified flying objects, described by the Press as "flying saucers", were the subject of a full intelligence study in 1951'.

Several unsuccessful attempts were made to trace this study but in 1998 the minutes of the DSI/JTIC were released [DEFE 41/74](#) and [DEFE 41/75](#). These revealed how the working party was established in August 1950 under these terms of reference:

- 1. To review the available evidence in reports of 'Flying Saucers'.
- 2. To examine from now on the evidence on which reports of British origin of phenomena attributed to 'Flying Saucers' are based.
- 3. To report to DSI/JTIC as necessary.
- 4. To keep in touch with American occurrences and evaluation of such.

The working party included intelligence officers from each of the three armed services. This team reviewed what was known about the subject and investigated a number of sightings reported to it by RAF Fighter Command. During their inquiries they questioned a group of test pilots from RAF Farnborough who had reported sightings of aerial

phenomena. In June 1951 the working party produced a final report that debunked the sightings and concluded that flying saucers did not exist. A surviving copy of DSI/JTIC Report No 7 was found in MoD archives in 2001. It was released in the following year in [DEFE 44/119](#).

Classified as 'Secret/Discreet' the six-page report concluded that all UFO sightings could be explained as misidentifications of ordinary objects or phenomena, optical illusions, psychological delusions or hoaxes. The working party concluded with the following statement: 'We accordingly recommend very strongly that no further investigation of reported mysterious aerial phenomena be undertaken, unless and until some material evidence becomes available.'[\(See DEFE 44/119\)](#)

The members of the working party relied heavily upon information supplied by the US Air Force UFO project (now renamed **Grudge**) and the CIA. US policy was to debunk the subject and restrict the release of information to the public about UFO sightings made by the armed services. A senior official from the CIA's Office of Scientific Intelligence, Dr H. Marshall Chadwell, was present at the meeting of DSI/JTIC in London during June 1951 when the report was delivered to MoD. American influence upon the team's methodology can be seen both in the adoption of the USAF term UFO in its title and the conclusions. Circulation was restricted within MoD with just one copy sent to Sir Henry Tizard.

4. Air Ministry investigations 1952-64

The conclusions of the Flying Saucer Working Party set the template for all future British policy on UFOs. After the report was delivered the team was dissolved and investigations ended. However, during the summer of the following year a new wave of sightings were made across the world. In July 1952, as Cold War tension increased, UFOs were detected by radars in the US capital Washington DC, prompting the USAF to scramble jet interceptors. The scare made headlines across the world and led Winston Churchill to send his famous memo to the Air Ministry on 'flying saucers.'

The Prime Minister was told on 9 August 1952 that 'nothing has happened since 1951 to make the Air Staff change their opinion, and, to judge from recent Press statements, the same is true in America' ([PREM 11/855](#)). In September this policy was dramatically reversed as a direct result of further UFO sightings that occurred during a major NATO exercise in Europe. The most dramatic were those reported by a group of Shackleton aircrew who saw a circular silver object appear above the airfield at RAF Topcliffe in North Yorkshire. In a report made to the base Commanding Officer one of the men, Flt Lt John Kilburn of 269 Squadron, RAF, said he watched as the object appeared to descend to follow a Meteor jet, rotated on its own axis and then accelerated away at a speed 'in excess of a shooting star' ([AIR 16/1199](#)).

According to Capt Edward Ruppelt, of **Project Blue Book**, it was the Topcliffe sighting that 'caused the RAF to officially recognise the UFO.' Soon afterwards the Air Ministry decided to monitor UFO reports on a permanent basis. Responsibility was delegated by the Chief of Air Staff to a branch within the Deputy Directorate of Intelligence (DDI (Tech) known as AI3 ([DEFE 31/118](#)). In December 1953 HQ Fighter Command issued orders to all RAF stations that in future reports of 'aerial phenomena' should be reported directly to DDI (Tech), Air Ministry, for further investigation. The order said it was important that details of sightings made by RAF personnel and from radar stations

should be carefully examined and its release 'controlled officially.' The Air Ministry letter stated that 'all reports are to be classified 'Restricted' and personnel are warned not to communicate to anyone other than official persons any information about phenomena they have observed, unless officially authorised to do so' ([AIR 20/9994](#)).

From 1953 reports from all sources were sent to DDI (Tech) for 'examination, analysis and classification'. Advice on likely explanations was to be obtained from Fighter Command, the Meteorological Office and the Royal Greenwich Observatory. Every year a special report 'summarising all UFO sightings by types' was to be submitted to the Air Staff ([DEFE 31/118](#)). None of these summaries have survived before 1956. However, an analysis of 80 reports up to 1954 formed the basis of an article published in Vol 10, No 3 of the Air Ministry Secret Intelligence Summary (AMSIS) during March 1955 ([DEFE 31/118](#) and [AIR 40/2769](#)). This summary, based upon a longer report now lost, was classified 'Secret - UK Eyes Only.'

The existence of this summary came to light in May 1955 when the Conservative MP Major Patrick Wall asked the Secretary of State for Air, in a Parliamentary Question, if he would publish the 'report on flying saucers recently completed by the Air Ministry.' In reply the Air Minister George Ward said: 'reports of "flying saucers" as well as any other abnormal objects in the sky, are investigated as they come in, but there has been no formal inquiry. About 90 percent of the reports have been found to relate to meteors, balloons, flares and many other objects. The fact that the other 10 percent are unexplained need be attributed to nothing more sinister than lack of data.' ([AIR 2/16918](#)).

The outstanding 10 percent of 'unexplained' sightings remained UFOs (or, as the Air Ministry preferred, 'insufficient information'). This explains the policy decision to continue collecting reports to the present day. The reasons given in the AMSIS article were that 'there is always the chance of observing foreign aircraft of revolutionary design.' This factor remained a concern for intelligence agencies until the end of the Cold War. The Air Ministry was careful to qualify this interest with this caveat: '...as for controlled manifestations from outer space, there is no tangible evidence of their existence.' ([AIR 40/2769](#)).

The Joint Intelligence Committee (JIC) initiated inquiries into 'aerial phenomena' on two occasions during the late 1950s. Following press reports of UFOs tracked by radars at **RAF West Freugh**, Scotland, in April 1957 the Air Ministry informed the JIC it was unable to explain four recent incidents ([CAB 157/27](#)). Aerial phenomena were again the subject of JIC discussion in March 1959 following a sighting made at London airport ([CAB 159/31](#)).

5. MoD investigations 1964-present

From 1958 a civilian Air Staff secretariat branch known as S6 (Air) took over responsibility for dealing with public relations on the topic of UFOs. During that year an S6 desk officer decided their policy would be 'politely unhelpful' in response to any public or press inquiry on the subject ([DEFE 31/118](#)). From this point onwards two separate branches of the Air Ministry were involved in dealing with the UFO problem. DDI (Tech) was responsible for investigating reports and assessing their defence significance, whilst S6 (Air) fielded questions from members of the public, the press and MPs.

In 1964 the Air Ministry became part of the new Ministry of Defence and the three separate service intelligence sections of the Army, Navy and RAF were merged under a new unified structure. S6's UFO remit passed to a new MoD secretariat, S4 (Air) and in 1967 responsibility for the investigation of UFO incidents deemed to have possible defence significance were inherited by a Defence Intelligence branch, DI55.

Although more than 11,000 UFO reports have been logged by DI55, S4 (Air) and a number of other MoD branches between 1959 and 2007, no detailed studies have been carried out on the accumulated data until relatively recently. Following a new wave of sightings in 1967 the Government faced a series of Parliamentary questions on their UFO investigations and policy. In response, the head of S4 (Air), James Carruthers, produced a detailed briefing for the Secretary of State for Air, Merlyn Rees MP. In his report dated November 1967 Carruthers says MoD had kept a statistical analysis of UFO reports received since 1959 'and has found no evidence to suggest [UFOs] have other than mundane explanations.' He added that MoD 'does not consider that a separate study by [UK] Government departments or by a university or other independent organisation would produce results to justify the expenditure, time and money involved.' (DEFE 31/119).

Following the conclusions reached by the Flying Saucer Working Party the MoD continued to reply upon studies carried out by USAF and CIA for their policy lead on UFOs. There was never any British equivalent of the publicly funded study by the University of Colorado on behalf of the USAF that was completed in 1969. The 'Condon report' - named after the project head, the physicist Dr Edward Condon - was based on an analysis of 12,618 reports collected by the USAF Project Blue Book between 1947 and 1969 (Blue Book followed Projects Sign and Grudge in 1952). Of this total 701 remained unexplained. The main findings of the US study were:

- About 90% of all UFO reports prove to be plausibly related to ordinary phenomena.
- Little, if anything, had come from the study of UFOs in the past 21 years that added to scientific knowledge.
- Further extensive study of UFO sightings was not justified in the expectation that science will be advanced thereby.
- No evidence came to light in the study to indicate that UFO sightings may represent a defence hazard.
- The Department of Defence should continue to handle UFO reports in its normal surveillance operations without the need for special units such as Project Blue Book (S4 briefing to MoD, 24 March 1970, copy in [BJ 5/311](#)).

Project Blue Book was closed by USAF following publication of the Condon report in December 1969. In the UK the MoD used the findings to further reduce their workload on UFOs. From 1973 members of the public who reported sightings received only a polite acknowledgement. Unlike the USAF, the MoD decided it should continue to maintain an interest in the subject so that it could answer questions from MPs and where necessary, reassure the public that UFOs posed no threat to national defence. This policy rethink, the first of many, took place between 1970 and 1975 and the papers can be found in [AIR 2/19086](#).

The last time the Government made a full public statement on its policy was in January 1979 when UFOs were the subject of a lengthy debate in the House of Lords. This was initiated by Lord Clancarty (Brinsley le Poer Trench), a ufologist who had written several books on the subject. Clancarty believed the MoD were covering up the truth about UFOs and he tabled a motion that called on the UK Government to set up an inquiry and for the Defence Minister to make a televised statement on UFOs. In the Lords, the Government's response was delivered by a retired Royal Navy officer and Labour peer, Lord Strabolgi (David Kenworthy). His closing remarks were: '...as for telling the public the truth about UFOs, the truth is simple. There really are many strange phenomena in the sky, and these are invariably reported by rational people. But there is a wide range of natural explanations to account for such phenomena. There is nothing to suggest to Her Majesty's Government that such phenomena are alien spacecraft' - [AIR 20/12966](#).

EDITOR: Well there you have it - a free look at everything (at least for the first month) the MOD has on file concerning UFOs providing you can access a computer. No 30 year rule, no cover-ups - but doubtless there will be those who will never be satisfied and need the adrenalin rush that only cover-ups and conspiracies can bring.

CIUFOR has visited the National Archive at Kew on 3 previous occasions over a 10 year period. The material available on our first visit was rather limited, being from the early 1950s to 1965 and could be browsed through in one day. By the time of our third visit later released files up to the early 1970s contained vast reams of mainly useless reports, each year taking up 2-3 files.

The material released on May 14th 2008 in 8 files contains cases only from the period 1981-7 and something like 1000 pages of reports, summaries etc can be viewed. Very little in the way of indexing seems to be available, so anybody investigating UFOs from a particular area needs to plough through page after page. The press appeared to be undaunted - for instance a zealous researcher for the Oxford Mail managed to locate 9 cases in Oxfordshire from October 1981 to October 1987.

Most national newspapers carried the story with the result that many new sightings and witnesses have suddenly emerged giving Ufology a slight bounce, but of course the MOD files themselves contain nothing new or sensational. David Clarke has done immense archive work and should be congratulated. CIUFOR will report on any MOD file which might be classified as "mysterious" over the next few years, and we also invite any members who can find the time to scan the files and report back to us details of cases that merit attention.

It is now confirmed that each of the 8 files available in the first release are available at £3.50 each to download from the National Archives, so a complete set of the 8 files amounts to £28.

DOGGED DAYS PART 2

EDITOR: We continue the blog style detail of Ellis Taylor's adventures into the unknown. Ellis experienced a missing time scenario on his drive to Lincolnshire (29/9/06) in Part 1. In this narrative he again visits the Andrews family in Long Sutton, Lincs, (24/11/06) and tries to ascertain what happened on the previous drive up there. He refers to Paul and Ann Andrews, their son, Jason, and wife, Jacqui, plus Ufologists Mike Oram and partner Fran, Sasha Christie, and Paola Harris who were staying at Andrews' house on the September trip.

I was aware that Ellis was most unwell around this time (Nov 2006) and established that bad energies appeared to be attached to his head. Later I confirm that I dowsed a cloud of unknown energy inside his car shortly after he had a nasty experience with it. Since producing this narrative, Ellis' health has improved and he has undertaken visits to America and Australia.

Sections referring to the Cornwall UFO and Probe conferences of 2006 have been omitted as they were not strictly personal activities. Dean Warwick, referred to in the text was the unfortunate speaker who collapsed and died on the platform at the Probe conference.

PART FIVE

Healing

Another conference I attended was the QuestCon in London on 28th October 2006. During Clive Prince's and Lynn Picknett's talk at this conference I noticed something about the 'Salvator Mundi' painting they showed and mentioned this to Clive Prince.

It was something that a friend said to me there that sort of inspired this article. We were chatting over lunch when he suddenly enquired, "Are you ok Ellis?" I knew that I wasn't, and hadn't been myself since the service station incident on my way to South Lincolnshire. That someone else noticed, and was concerned enough to ask, was touching and I knew that I had to do something. I don't know why I didn't think of it before. Perhaps I needed the trigger that Paul gave me and that enabled me to reconnect. On the train journey home I knew exactly what to do. All I needed was to ask for healing, which I did and immediately began to feel better.

A few days later I was relating the events at the Andrews' to Geoff Ambler, the vice-president of the long established Contact International UFO Research Group. Geoff is a dowser, as well as a researcher into all things supernatural. After I left he dowsed my energy signature and was concerned that I had 'picked up' some negative presence. The following Wednesday (8th November) at a Contact International Group meeting he dowsed my energy field and claimed to discover two (*spirit*) attachments, one either side of me. When I looked around to watch his pendulum it would stop, which would happen when I closed my eyes as well. He felt that these were harmful presences and decided he should remove them. I was less certain because I know that I have two guardians. They

are *reptilians*, dragons then, fully armoured. I was concerned that what he was going to do would in some way hamper them. Geoff said he had done the deed.

During the next night (Thursday) I was awoken by scratching, the same scratching sound I had heard at Paul and Ann's while sleeping on their sofa. I'd tried to move but couldn't and no matter how hard I tried to I could not call out. It seemed the longest time that I was like this and then eventually I managed to cry out and immediately the spell was broken - I could move again. My *spacey-ness* returned, though not as drastically as before, and I spent the next day in a sort of haze.

On the Friday night I was well enough to remember what I should do and asked for healing and my protection to return. Come Saturday morning I was feeling great. I called in to see Geoff on the Sunday and he dowsed me again saying that he could pick up nothing negative but remembering a previous experience he said he would like to dowsed my car. As soon as he reached his pendulum into the car it span like mad. He performed his stuff on it and the pendulum's lack of movement confirmed to him that all was now well.

I didn't tell him about this but on my way to visit him I had dropped by to visit another friend. They live on a hill close to St Mary's Church in Garsington. Their drive is steep so I engaged the handbrake as well as put the car in 1st gear when I parked. As I arrived my friend was in the drive. We had been chatting for about 5 minutes when I saw a car speed past towards the centre of the village, just at that moment my car whizzed quickly down the slope and crashed into the bank on the other side of the road. I ran down after it and found the handbrake had been released and the gears stick in neutral. This could have ended tragically but fortunately no people or other vehicles came by at that moment. My car has only recently been tested (MOT) and has behaved properly ever since. It makes me wonder, "Did Geoff's pendulum truly pick up something sinister?"

Return to Long Sutton

Orb phenomena in the front garden of the Andrew's house. In this same spot strange creatures have been observed - and photographed.

Now, it might seem to some that I am a glutton for punishment but I have just returned from another weekend staying with the Andrews. Paul, Ann and Jason

are really good friends and I enjoy my visits. Nothing like what happened at the end of September has ever happened to me before at their house. I've seen some strange things, UFOs and strange mists etc. I've woken up with marks on my body too and a feeling that something had occurred but I can never remember what. One vital reason for the visit was that I wanted to confirm the events of my last visit for this article. (1)

On Friday, 24th November I set off for Long Sutton at the same time as the previous visit and arrived at about 4pm. On the way I wanted to stop at the service station so that I could see if things were any different (or the same). For some reason I did not see it. Whether it was hidden by lorries I don't know. On my way back though I think I did spot it. I couldn't miss the huge signs announcing 'McDonald's'. How odd that I didn't remember what the fast-food outlet was!? As well, the restaurant was down below the road. I remembered having to drive up a hill and then down onto the carriageway when I left. (It may be that that is the case but I couldn't see the full site from my vantage point this time.)

Now, before I go on, I want to tell you about something else that happened to me. It was just after 7pm, about 7.10, on Thursday 23rd November (the day before I was to leave for Long Sutton again). I was typing on my computer when suddenly my head began to spin; I could not focus my eyes and I felt violently sick. At the same time, it is hard for me to describe this, but it was like all that was left of me was my essence. I crawled over to the side of the bed leaning against it, my mind reeling, my eyes closed, and I felt this intense cold. Everything was silent. I called out for my guardians to help and at once I began to recover. Still feeling completely drained I attempted to resume my writing but I was shaking and exhausted. Switching the computer off I decided to rest. The next morning I still felt unwell and considered cancelling my trip. For part of my journey I found myself taking a route that I hadn't used before and it was during this section that I instantly began to feel completely better. Nothing out of the ordinary happened over the weekend but I was able to find out a little more concerning my mysterious arrival on the previous occasion.

Ann and Paul are sure that I arrived when it was dark and that it was not raining when she opened the door to me.

There was one other person I could ask, which I hoped would settle the matter once and for all; and that was Jason. When I turned up this time Jason and Jacqui were busy working on their car in the garage. Ann and Paul made me a cuppa and while we were sitting chatting Jason and Jacqui came in. A bit later in the conversation I turned to Jason and said, "While I think about it Jace..."

"Six!" he said, before I could go any further.

"Six what?" I asked (knowing full well that he had read my mind – which he does with anyone, and with ease. Mind you, I have had quite a few successes, in the past, sending thoughts intentionally during private experiments).

"How do you know what the question is?" Ann and I asked in chorus.

"Well finish the question and the answer is 6," Jason smiled.

"What time did you arrive on that Friday mate?" I enquired.

"Six, I told you," he grinned.

"No, it wasn't, that was when we phoned after picking Sacha up," said Jacqui.

"Don't you remember?...So it must have been about 6.30ish when we got here."

To tell you the truth, I'm more confused than ever by this time. Anyway I

left it. Later that evening I was telling them all about what had happened to me the previous evening. I had only got to the bit where my eyes could not focus when Jason said, "EMP" (electro magnetic pulse weapon). "The same thing happened to me twice when I was in Italy, in the hotel. It is horrible...Did your aura disappear? Mine did; and it took a long time before I felt well again. " That, I would say, is precisely what happened to me, my aura was dissolved, taken, whatever. I tried to describe it by saying that all that was left was my essence. But I have my aura back now.

I also showed Jason the red patch on the base of my neck – which had returned to dark red again after the Thursday evening episode. "That's radiation!" he said. When I have returned from my *otherworldly* encounters I almost always have a kind of sunburn; it's sore, and usually very red. I very often have an upset stomach too. After the episode with the dogs you will recall that I told you how my hair was falling out and my beard stopped growing for a number of days. A frequent memory of several occasions has me in a very bright room with figures in what look very like the white decontamination suits you see.

Two days after my return from Long Sutton I discovered that the person who Dean Warwick had claimed to know from Scotland had experienced something very similar, on the previous day, to what I had on that Thursday. They were left partially and temporarily paralysed. I am pleased to report that they too are ok now.

End Notes

1. A few days prior to my leaving for Long Sutton, this time, I had an email from Fran in which she gave me her recollections of my arrival on the previous visit. It confuses me even more. Where Ann, Paul and I remember Ann opening the door to me when I turned up Fran says that she thought she did. Fran writes:

"I thought I opened the door to you! I definitely opened it to someone and it wasn't Jason and co cos I was sitting on the settee when they arrived. The only other person who arrived was you.

I am confused as to whether it was just getting dusk or was actually dark. I feel that when I opened the door it was still lightish but my memory of us all in the conservatory is that it was quite dark - and we were really only in there, at the most, 10 - 15 minutes I'd guess, after you arrived. Also, I had only just gone into the conservatory and don't think I was sitting down but was still in the doorway by the end of the sofa when Paola saw you. I feel that when I was in the conservatory it was starting to rain cos I heard it on the conservatory roof but when I opened the door you were not wet and I don't remember it raining outside.

Ann came out of the kitchen, greeted you and we all went into the conservatory. Once in the conservatory you sat at the little table. Ann asked if you'd like a cup of tea and went off to make it. I asked you if you were OK as I felt you weren't and you said you felt a bit 'weird' and could you have something to eat. (That was when I noticed your hands were shaking). I asked if you had eaten that day and then I went into the kitchen to speak to Ann and said, "I think he could probably do with something to eat." I thought I then came back and Ann followed me and asked if a cheese sandwich would be OK.

It is almost as if there were 'two' arrivals! Sure there can't have been. (?!)"

2. I don't know either, but the surveillance, or my awareness of it, seems to have begun during a time in my life when I began to talk publicly about my *otherworld* experiences. This was concurrent to a time when I was receiving vivid visions that at times showed scenes apparently pertinent to disasters, crimes and other incidents. For example the Claremont murders, Sarah Payne, 911 and Thredbo. The wave attacks were intermittent and were not so violent then. (See photo left)

These, however, increased in potency (or my susceptibility to them did) when I began speaking at conferences about my experiences.

An end of an era, or is it?

On the 1st January 2008, I decided to close the Southampton UFO Group and ended the group's 18-year history. Why? It becomes impossible to run any type of group single handedly and with the passing of my father in December 2007, something had to give. So, having closed the group that I started in 1990, I have decided to carry on with the group's magazine and in September 2008 the magazine will be re-launched under a new banner. British UFOlogy has lost another UFO group and I feel that the magazine is needed to plug the gap, as there are very few British UFO magazines available.

So, the next question is has ET realized the group has closed? Between the 1st January and the 1st March there has been a rash of sightings in Hampshire and the Isle of Wight totaling 17 to date (15th March). On the 3rd March the Southampton Evening Echo informed me of a further 3 sightings that occurred on the 9th February (now 5 in total). The same period in 2007, the Southampton UFO Group had received just 4 reports and only received 48 UFO reports for the whole of 2007.

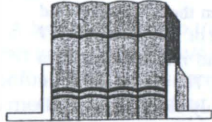
So why have we seen an increase in sightings over the Hampshire & Isle of Wight area? The area is not known as a 'typical' UFO hotspot and of the reports, 9 took place after 5 pm in the evening so making the sightings more difficult to explain. Never the less, a couple of reports had between 2 - 4 witnesses making a better correlation of the object(s) seen. Hampshire has its share of military bases, airports, harbors (Naval) and just sheer bloody minded people happy to release Chinese lanterns across the skies of Hampshire. There has been 4 reports of multiple objects ranging from 4 - 10 + objects and one starts to think of the trusted Chinese lanterns, but the descriptions do not match the description of the 'typical' Chinese lantern (But what is a 'typical' Chinese lantern?). As I type this, there have been no further reports for the past 4 weeks so what caused the rash of sightings over just a 6 week period over Hampshire? We will never know the real answer, or will we?

BOOK REVIEW.

I met the author of this book when she and I were invited (along with others) to speak at an International UFO Conference over in Carrick On Shannon Ireland last year (2007) I sat fascinated as I listened to Yvonne's lecture on her first hand experiences with UFO abductees and was amazed at the power point slides that she put up on screen each one showing in graphic detail the small grey 'beings' as they poked and prodded their helpless victims. And that's the thing, the helplessness that UFO abductees find themselves in when they are suddenly catapulted into the 'Twilight Zone' (for want of a better word)

There are many hundreds of people spread out throughout the world who are involved in UFO abduction research and a good number of those are doing so through hypnotherapy and using it as a tool to hopefully retrieve any hidden subconscious memory of their abduction event that might, just might, help to explain if it really happened at all or if it is all in the mind. Having looked at this subject myself for over 20 years, I am of the firm belief that we are indeed somehow interacting with some form of non human intelligence, now what exactly that 'alien' intelligence agenda is, is of course open to question and interpretation.

Yvonne initially had absolutely no interest in matters pertaining to UFOs and aliens, she of course had heard about it (as we all do) through TV and sensationalised press reports but initially dismissed these reports as over active imaginations, that was however, before her mother handed her a book to read entitled, "The Tujunga Canyon Contacts written by Anne Druffel. This book described the use of hypnosis to unlock the memories of two women who shared a UFO experience. However, it wasn't so much the actual UFO incident that intrigued Yvonne, it was more to do with the use of hypnosis at getting at what could be termed the truth, or trying to explore the truth, whatever that truth may be. This set Yvonne off on a one woman crusade where she learned that hypnosis was not just about making people act and quack like a duck, that it had its more beneficial purposes. She perused the writings of the American Medical Association and poured over as much information as she could get on the use and workings of hypnosis and the mind. It wasn't long before she found herself enrolling in a local hypnosis class of which she graduated from.

Not long after she graduated from her hypnosis school, Yvonne and her mother attended a Whole Life Expo in Pasadena California which amongst other things, had aspects on hypnosis and UFOs. It was during her visit to this Conference that she encountered and listened to one Budd Hopkins who himself was making a name for himself in the world of

UFO abductions. Back in Yvonne's home town she started her own hypnosis classes which brought forward a number of local people with ailments from heavy smoking and weight problems, each who looked to Yvonne to do something about. Whilst working with these people, she began to realise that a number of the people that she was working with, put down their problems to a UFO experience. This was puzzling to Yvonne and set her out on a course that would change her life.

Soon Yvonne was working with what we would term as 'UFO Abductees' and this book highlights but a few of her more startling cases that she found herself involved with. What I'd like to do now is basically discuss some of the points that Yvonne makes in her book because as we'll see, some points have a relevance to one major Scottish case that I worked on some years ago.

Are 'aliens' clever? I say this because on one case that Yvonne refers to, the Laci Case, the lady in question had been scuba diving when she was abducted and on board this craft (or whatever it was) the aliens were puzzled as they looked down and prodded her wet suit thinking that it was part of her 'skin'! Yvonne makes the clever recall about the Betty and Barney Hill abduction when the aliens found out that Barney's teeth could be removed and Betty's couldn't (so much for intelligent aliens) It's small things like this, that puzzle me as a researcher that aliens can be so damn stupid. If they are so highly advanced to us why get something like this so far wrong or not be able to understand it, it just beggars belief. Staying with this case for a moment, Laci explained to Yvonne that as she came out of hypnosis her abdomen was very painful which Yvonne explains that the mind can retain physical memory pain and bring it back into the conscious after hypnosis (but generally for a short period of time, in other words, the Abductee can feel the pain that they encountered during their abduction) Now, it's this pain, the abdominal pain that one of the Scottish UFO abductees that I worked with, Garry Wood, experienced. He related to me that he felt extreme abdominal pain like his insides were all twisting and turning each and every way like a large hand was inside her stomach pulling and pushing his guts each and every way. This abdominal pain is very consistent with other UFO abductees.

Moving on to another of Yvonne's case studies, a lady called Mary, I again came across similar incidents to my own Scottish UFO Abduction case (The A70 Case) Mary related a scene that she recalled under hypnosis when she herself had been abducted into a UFO where she observed a number of 'people' encased in some kind of glass or Perspex room which had mist or a fog swirling all around inside of it. These people were naked and strapped to a chair. Not only did she see the small grey 'aliens' but there were a few taller ones in there as well, (exactly what other UFO abductees claim, including Garry and Colin from the Scottish case) Further on in this case, Mary makes this quite amazing statement, and I quote it in its entirety.

"The reason they care about our behaviour, is that it will affect them too. They live here but not well and not comfortably. I get the impression that they don't even exist on a day to day level in the same dimension on this planet as us. They rotate into our world as needed and out into their own dimension here, in which they are barely hanging on. I get the feeling that they can't endure our sunshine, our gravity our geomagnetic fields our

high octane emotions for long. They've managed some kind of half existence here. Whatever we're doing that will have systematic global impacts on us and the economies which we depend will make their tenuous existence even less tenable, even impossible"

Mary goes on to say that she gets the feeling that the 'aliens' are out to manipulate our genetic material to create bodies that are fully adaptable to 'their planet'

Mary goes on to describe even further what she thinks is behind all this (UFO Abductions) but I won't spoil it here by telling you, you'll have to buy Yvonne's book to find out.

In another case study in Yvonne's book, again there is a similar thing to what happened in the Scottish A70 UFO Abduction case that I worked on. One lady Katie Campbell, during her abduction, remembered being placed in what looked like a dentist's chair, a contoured chair, now that is exactly how Colin Wright, the other gentleman in the A70 case mentioned being placed in.

Another puzzling case in Yvonne's book refers to John who was abducted from his car back in 1980, during and after John's hypnosis, he realised that things were not so cut and dried in our lives as we might care to imagine, that perhaps our real parents come from the stars and that like kids who are adopted never really knowing who they're real parents were, set off on a crusade to get to the truth and find out who they're real parents are, and in a sense, he related to Yvonne, I too feel like that. And that's the thing ladies and gentlemen, the thing that brings us all to ask the question, how did WE evolve here on this planet, did we come from the apes as Darwin would have you believe, or were we the result of some intergalactic experiment that somehow is 'still going on' Questions questions.

Yvonne's book holds many similar Abductee stories from the implants to the bright lights to the examination rooms etc etc. There is a lot in this book that I'm sure many abductees can relate to. There are of course differences as well and it would appear that no two abductions are the same, there does appear to be differences, and that's another thing. If it were all the same wee guys doing the abductions, then you would expect (possibly) the abduction to follow the same pattern, but they don't, so does this mean that we are dealing with different alien races? A lot of researchers would say so. One chap in the book Alfonso stated during his hypnosis session with Yvonne, that the aliens showed him gigantic earthquakes, tidal waves and volcanoes going off at all points of the planet earth, the whole world that we currently know is going to be changed forever but after thousands upon thousands of years, it will all settle back down, however not as we know it, but back to tropical forests etc. Alfonso did not want to see anymore of this by his alien captors and had to look away.

Yvonne explains to the reader in her book that sometimes she 'does' ask 'leading questions' to her patient under hypnosis. Now we all know that hypnotherapist should not be asking leading questions, but as Yvonne explains, there is a time and place to do so, which usually brings forward even more information that wouldn't have been gained in the

normal way of asking. It's the understanding on when and how to see the leading question that is important.

One of the most illuminating case studies in this book is the double abduction of brothers Jesse and John. God almighty what a case this is. There are implants, (of which photographs are shown in this book) and there is some disturbing and alarming testimonies coming from both brothers. However, what I found most intriguing as I'm sure the reader will, is 'after' the UFO abduction John found himself deeply interested in inventions and coming up with ideas way out of his box. So much so, that when he put into the USA patent office of a invention that he had, an Ellipsoid Generator he was told in no uncertain terms that his request for a patent had been denied for a period of six months until the Government officials looked over his patent to see if it breached any secrecy orders !!! He never did get the permission so what he did was to.....Well read the book and find out.

Like many other UFO abductees, John had visions of impending catastrophes that would happen in the near future and his vision of two twin towers crashing to the ground, well sadly we all know what happened there.

All in all then I found this a most enjoyable read, and although the vast majority of it was very similar to other UFO abductions, there were enough differences and similarities to my own Scottish case to make me sit up and take note. Yvonne's journey from a hypnotherapy student to dealing with traumatic case studies on UFO abductions has shown her that the world we live in is surely more stranger than we can ever imagine. Is it all in our mind, can mankind share the same global psychosis (if that is indeed what it is)? What's going on? For me as a writer and researcher, I would say that we are indeed dealing with some kind of alien intelligence, that hypnosis, if used properly, can bring forth recall from events that would seem to show us that what the witness claimed is real.

Mankind has a right to question, you the reader have a right to know what's going on, what could be even more alarming than the cases in Yvonne's book, might be the fact that the Governments of this world know more than they are letting on when it comes to UFO abductions. We need more books of this nature we need to show the world that mankind, is not the only living breathing organism in the universe, that we share that universe with beings more intelligent than us but more distressingly do not always have our best interest's at heart.
